Thank you very much for helping the Shelsley Walsh Hill Climb appeal by purchasing the custody of four square yards of the historic track. The club's support is very much appreciated. The name on the certificates will appear along side the square number beside a map of the hill at Shelsley in the future.

The appeal has now exceeded £ 850,000 and, therefore, has raised sufficient funds to pay the landlord the lease premium for the next 99-years. This figure combines the funds raised by the Trust, the shares purchased in Shelsley Walsh Hill Climb plc and money contributed by the Midland Automobile Club. The funds raised by the Trust have been used to purchase shares in SWHC plc, who will be the lease-holder. The Trust is the largest shareholder in SWHC plc.

Fund raising is continuing to cover legal costs, insurances, stamp duty etc., and, equally importantly, to support the renovation of the extensive farm buildings.

The Trust will work with both SWHC plc and the MAC to ensure that motor sport continues at Shelsley, with improved facilities for both spectators and competitors.

Again, we are most appreciative of your support, and I hope that we will be able to enjoy the hill climbs at Shelsley for many years to come.
